Terms of Agreement – Contract

We the undersigned for and in consideration of permission and space to participate in this event, agree to indemnify, hold harmless and defend the Lewiston Heartland Days Committee, its officials, representatives, agents, employees, and volunteers from and against any and all claims, actions, lawsuits, damages, judgments, liability and expense, including attorney fees and litigation expense, in whole or in part arising out of, connected with or in any way associated with my/our activities preparing for, participating in, or departing from the event. I have read and fully understand the above Hold Harmless and Indemnification Agreement.

I understand that the local paper(s), the City of Lewiston, and the Lewiston Heartland Days Committee reserve the right to photograph and/or record participants and the items they bring with them for potential future use. I hereby grant permission to them to use my or my participant's photograph and/or audio/video recording for any lawful purpose, including for example such purposes as print and online advertising. I understand that I will not be paid or receive anything related to the use of my/my participant's photograph and/or recording. I understand all photographs and recordings will remain the property of the Lewiston Heartland Days Committee. I acknowledge their right to alter or edit any photographs and/or recordings at its discretion.
